As per clause (vi) of section 2 of the Kerala Local Authorities (Constitution and Preparation of Electoral Rolls) Act, 1994, district panchayath area means the rural areas within a district to be notified by the Government for the purpose of clause (c) of Section 3 of the said Act. Government have decided that the district panchayat area in each district in the State shall be the area covered by the village panchayats in that district.
